Corporate membership or a similar professional qualification obtained from recognized professional institute in the relevant field with at least 11 years' of post qualifying experience in managerial level, out of which 05 years should be in senior managerial level in the relevant field

**or**

Post Graduate Degree in the relevant field with corporate membership or similar professional qualification obtained from a recognized professional institute in the relevant field with at least 09 years' of post qualifying experience in managerial level, out of which 4 years should be in senior managerial level in the relevant field

## ASSISTANT DIRECTOR (FINANCE) -01
