1. Works are as follows.
  - i. Infrastructure Development of "Asidisi Medura"  
The Construction Period is **175 Days**.
2. Bidding will be conducted through National competitive Bidding procedure.
3. Bidders should comply with the following eligibility criteria to qualify for award.
  - i. Valid business registration.
  - ii. ICTAD registration C2 and C3
  - iii. Average Annual volume of construction work performed in last 5 years should be at least Rs 243 Million
  - iv. Should have completed at least 41M worth of average annual turnover work during any of the last five years

Bids will be opened immediately after closing. Bidders or their representatives may attend the bid opening.
